Sub : Revision of Income Ceiling under the Centrally Sponsored Scheme of Post-Matric Scholarships to the students belonging to Scheduled Tribes for studies in India with effect from the financial year 2010-11 i.e. from 1-4-2010.

Sir,

I am directed to refer to the above-mentioned subject and to say that the Government has decided to revise the existing Income Ceiling of Rs. 1,08,000/- (Rupees one lakh eight thousand only) per annum per student as contained in para IV (Mean Test) in the Scheme of Post-Matric Scholarships to the students belonging to Scheduled Tribes, for studies in India – Regulation Governing the Award of Scholarship, to Rs. 1,45,000/- (Rupees one lakh forty five thousand only) per annum per student, linked to the Consumer Price Index for Industrial Workers up to October 2009, effective from the year 01-04-2010. The Post-Matric Scholarships for the current financial year may be disbursed accordingly.

2. The State Governments and Union Territory Administrations are also requested to give wide publicity to the above decision through various media outfits and through State and District Administrations, including various Academic Institutions.


